ORDER ON MOTION FOR PROTECTIVE ORDER

This matter is before the Court on the motion of Plaintiffs Forward Montana, Leo Gallagher, Montana Association of Criminal Defense Lawyers and Gary Zadick seeking a protective order to stay discovery pursuant to Montana Rule of Civil Procedure 26(c)(1). Defendant State of Montana (State) opposes.

Raph Graybill, Rylee Sommers-Flanagan and Constance Van Kley represent Plaintiffs. Assistant Solicitor General Brent Mead and Assistant Attorney General Patrick M. Risken represent the State.

Pursuant to Montana Rule of Civil Procedure 26(c)(1), a "court may, for good cause, issue an order to protect a party or person from ... undue burden or expense" by issuing a protective order while the action is pending. Plaintiffs seek a protective order to stay discovery pending resolution of its motion for summary judgment. The motion for summary judgment is unrelated to the information the State seeks and may resolve this case on the merits. According to Plaintiffs, staying discovery when a dispositive motion is pending supports judicial economy, efficiency, and the just and speedy resolution of the matter. Moreover, because this Court has previously determined Plaintiffs have standing, the issue upon which the State seeks discovery is no longer at issue and the State has preserved its objections. The Court agrees.

Accordingly,

ORDER

IT IS HEREBY ORDERED the Plaintiffs' motion for a protective order to stay discovery is **GRANTED**.
